By placing an order through our website or directly with our team, you agree to the following terms and conditions.

1. Products and Services

- 1.1. We offer hardware products (e.g., electronic modules, lighting systems) and software solutions (e.g., monitoring platforms, control apps) tailored for marine and yacht applications.
- 1.2. All product specifications and descriptions are provided for information only and may be subject to updates or improvements.

2. Orders

- 2.1. Orders can be placed via email, our official online store, or directly through authorized representatives.
- 2.2. An order is considered accepted once we send you an order confirmation by email.
- 2.3. Yacht Concept Sp. z o.o. reserves the right to reject or cancel any order, especially in cases of errors in availability or pricing.

3. Prices and Payment

- 3.1. All prices are listed in EUR and exclude VAT, depending on the buyer's location and VAT status.
- 3.2. Payments must be made via bank transfer, credit card, or other supported methods.
- 3.3. Payment terms: advance payment.
- 3.4. We reserve the right to change prices at any time before the order is confirmed.

4. Delivery

- 4.1. We deliver worldwide via trusted couriers.
- 4.2. Shipping costs and estimated delivery times will be provided during checkout or upon order confirmation.
- 4.3. Risk of loss and damage passes to the buyer upon delivery.
- 4.4. Any customs duties or import taxes are the responsibility of the buyer.

5. Warranty

- 5.1. Our products are covered by a 24-month limited warranty from the date of delivery, covering material and manufacturing defects.
- 5.2. The warranty does not apply to damage caused by misuse, unauthorized modification, or incorrect installation.
- 5.3. Software is provided "as is" unless otherwise specified.

6. Returns and Complaints

- 6.1. Returns are accepted only upon prior agreement and within 14 days from delivery (for consumers under EU law).
- 6.2. Returned goods must be unused and in original packaging.
- 6.3. Custom-made or software products are non-returnable unless defective.
- 6.4. Complaints must be submitted in writing within 7 days of discovering the issue.

- 7.2. Reproduction, resale, or distribution without prior written permission is prohibited.
